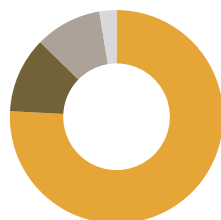

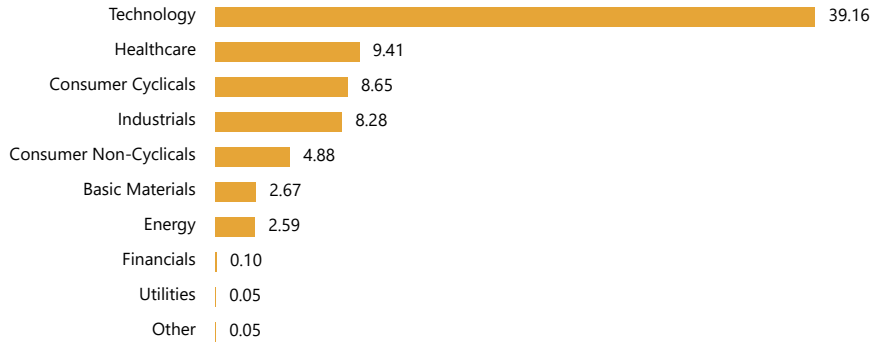

SECTOR BREAKDOWN (%)



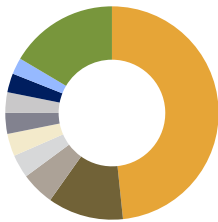

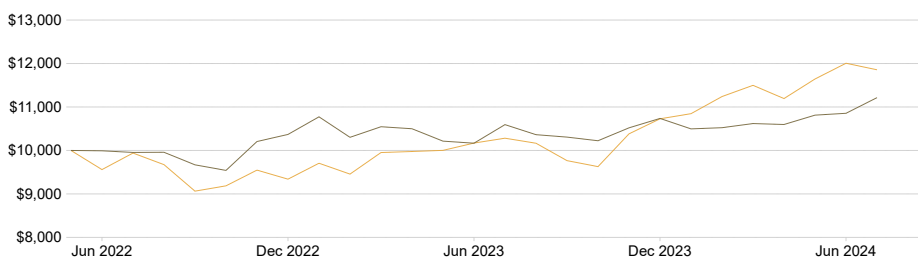

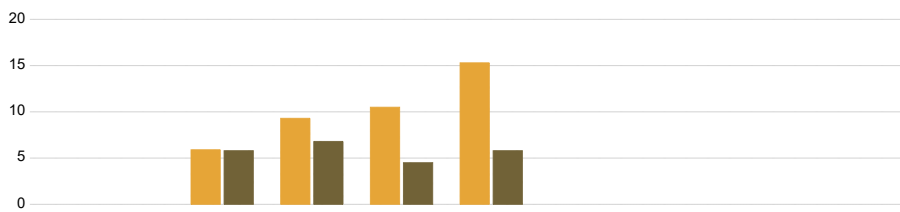
GROWTH OF \$10,000 INVESTMENT

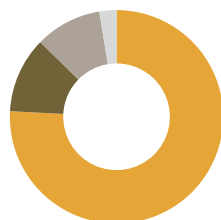

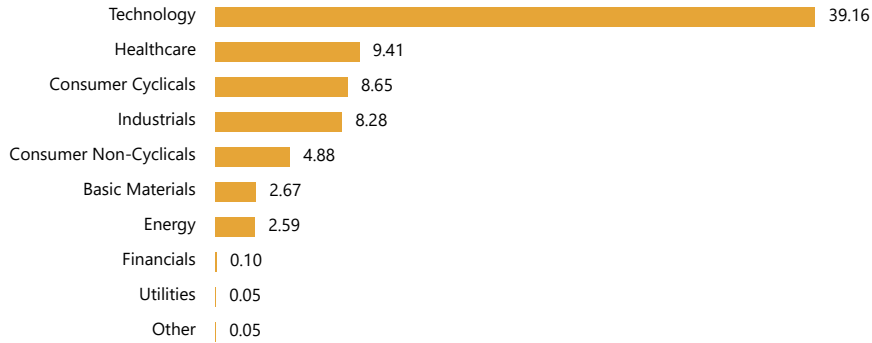

SECTOR BREAKDOWN (%)



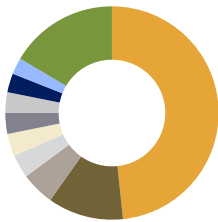
