


INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to primarily provide income and possible capital growth over medium to long term by investing in a portfolio of sukuk, Shariah-compliant equities and/or Islamic collective investment schemes and channel a portion of the income for waqf purposes. The Fund seeks to achieve its investment objective by investing between 30% to 70% of its NAV in MYR-denominated sukuk and between 30% to 70% of its NAV in Shariah-compliant equities and Shariah-compliant equity-related securities here include Shariah-compliant warrants, rights issues, Shariah-compliant American Depositary Receipts and Shariah-compliant Global Depositary Receipts.




