### 1. What is Maybank Enhanced Cash XIII Fund?

The Fund is a money market fund that aims to provide income on quarterly basis, subject to availability.

### 2. Fund Suitability

The Fund is suitable for Sophisticated Investors\*:

- with a short term investment horizon;
- who have a low risk tolerance;
- who seek a regular income stream<sup>^</sup> from their investments; and
- who wish to obtain a yield that exceeds the Maybank overnight deposit rates.

\* Please refer to the definition of “Sophisticated Investors” in the master information memorandum for more details.

<sup>^</sup> Regular income stream is dependable on the choice of distribution mode selected by unit holders. The income could be in the form of cash or units. Please refer to item 7.6 on Income Distribution Policy and Distribution Mode in the master information memorandum for more details.

### 3. Investment Objective

The Fund is a short term money market fund that invests in instruments which generate income. The Fund aims to provide regular income that is potentially higher than prevailing money market and traditional bank deposits, stability of capital and a high level of liquidity. The Fund aims to distribute income on a quarterly basis.

<b>Investment Style &amp; Strategy</b>	<p>The Fund seeks to provide liquidity to meet the short term cash flow requirements of its unit holders by investing primarily in liquid, low risk and short term investments.</p> <p>It will seek to obtain a yield that exceeds the benchmark by placing up to 100% of the net asset value (“NAV”) of the Fund in short term fixed deposits.</p> <p>The Manager adopts an active investment strategy in managing the Fund in order to provide a reasonable level of return within the liquidity requirements.</p>
<b>Manager</b>	Maybank Asset Management Sdn Bhd.
<b>Management Fee</b>	Up to 0.45% per annum of the NAV of the Fund.
<b>Sales Charge</b>	The Manager will not impose a sales charge.
<b>Redemption Charge</b>	The Manager will not impose a redemption charge.

<b>Switching Fee</b>	RM10.00 per switch.  <i>Notes:</i> (a) The Manager reserves the right to waive or reduce the switching fee at its absolute discretion. (b) In addition to the switching fee, the Unit Holder will have to pay the difference in sales charge when switching from a fund with lower sales charge to a fund with higher sales charge.
<b>Transfer Fee</b>	RM10.00 per transfer.  <i>Notes:</i> (a) The Manager reserves the right to waive the transfer fee. (b) The Manager reserves the right to decline any transfer request if such transfer will expose the Manager to any liability and/or will contravene any law or regulatory requirements, whether or not having the force of law.

<b>Trustee Fee</b>	0.05% per annum of the NAV of the Fund, subject to a minimum fee of RM18,000 per annum.
<b>Minimum Initial Investment</b>	RM250,000 or such other amount as may be decided by the Manager from time to time.
<b>Minimum Additional Investment</b>	RM250,000 or such other amount as may be decided by the Manager from time to time.
<b>Minimum Units Held</b>	50,000 units
<b>Distribution Policy</b>	The Fund will distribute income on a quarterly basis, subject to availability.

## 6. Key Risks

### Specific Risks

#### (1) Interest Rate Risk

Interest rate fluctuations do affect the fixed deposit returns of the Fund. Interest rates offered by the financial institutions will fluctuate according to the overnight policy rate determined by Bank Negara Malaysia and this has direct correlation with the Fund's investment in fixed deposit. The Fund's investment in fixed deposits will benefit from higher interest rate and in the event that the interest rate is low the Fund's returns will also be low. Changes in the level of interest will cause prices of money market instruments to change inversely. This risk can largely be eliminated by holding the instruments until maturity, thereby locking in price and yields.

#### (2) Deposit Account Risk

When the Fund places monies into the fixed deposits, profits are safeguarded by the financial institutions. However, their investment is not without risk. In the event that the financial institutions become insolvent, the Fund may have difficulty getting back their money.

*Investors are reminded that the risks listed above may not be exhaustive and if necessary, they should consult their adviser(s), e.g. their bankers, lawyers, stockbrokers or independent professional advisers for a better understanding of the risks.*

## 7. Valuation of Investment

The Fund will be valued at 11.30 a.m. every business day. The valuation of the Fund will be carried out in a fair and accurate manner.

## 8. Exiting from Investment

Submission of Redemption Request	The cut-off time for redemption of units shall be at <b>4.30 p.m.</b> on the previous business day.
Payment of Redemption Proceeds	<p>The Manager will pay the redemption proceeds to unit holders on T* + 1 day.</p> <p>However, if the total redemption amount for that day exceeds 50% of the Fund’s NAV, the Manager reserves the right to pay the redemption proceeds to the unit holders within 30 business days from the day the redemption request is received by the Manager.</p> <p><i>Note: T is the day where a request/application to redeem is received by the Manager before the cut off time.</i></p>
Remittance of Redemption Proceeds	The Manager shall remit the redemption proceeds to the account held in the name of the unit holder(s).

*For both creation and redemption of units, the Manager shall not be held responsible for any delay or loss incurred in the event of:*

- *Real Time Electronic Transfer of Funds and Securities (RENTAS) experiencing problems;*
- *Any remittance of fund that does not correspond with the request promptly;*
