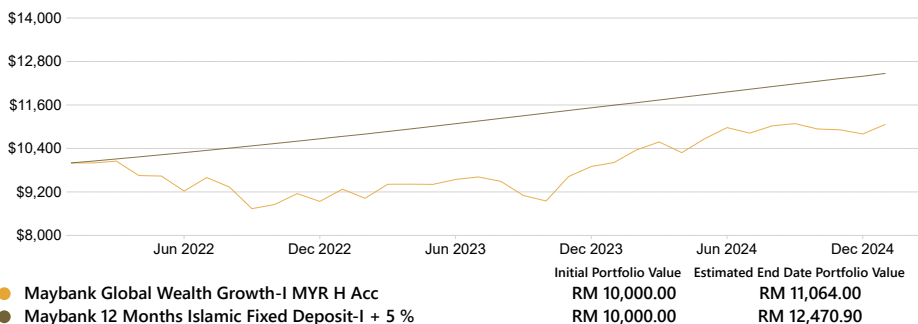

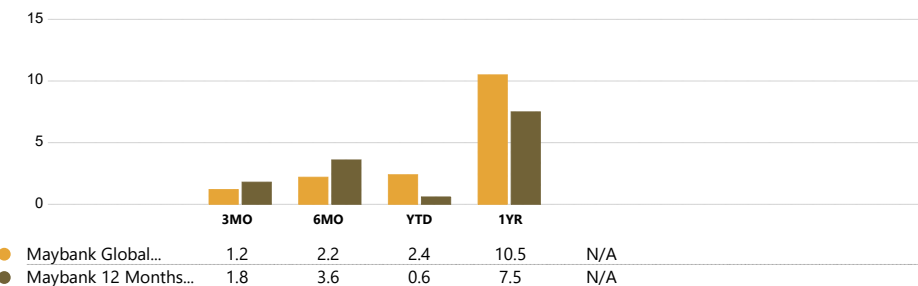
INVESTMENT OBJECTIVE AND STRATEGY

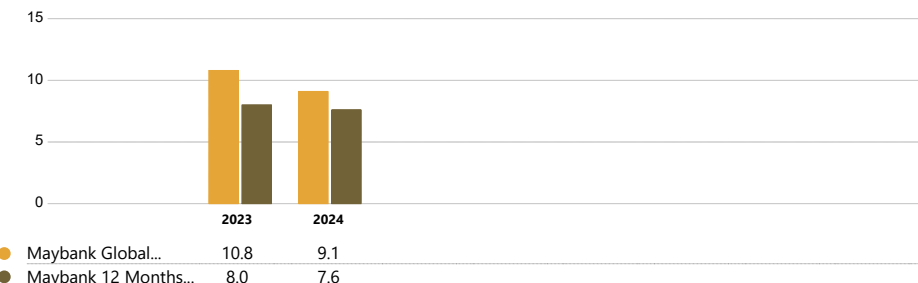
GROWTH OF \$10,000 INVESTMENT



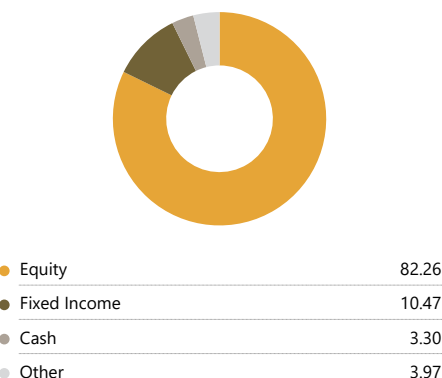
ANNUAL COMPOUND RETURNS

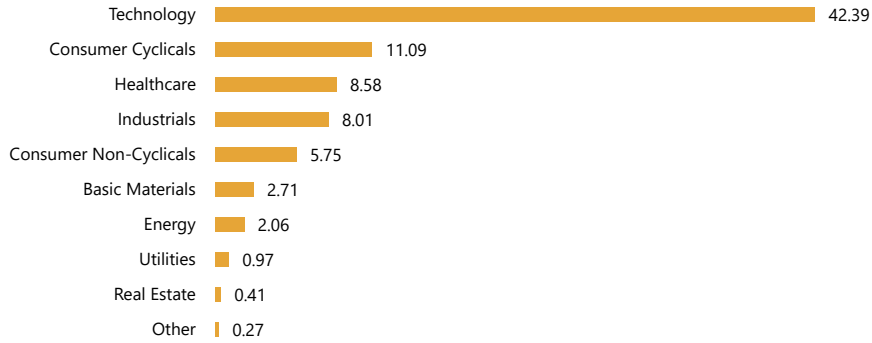

SECTOR BREAKDOWN (%)



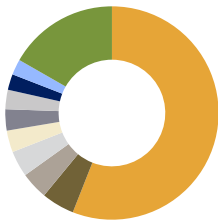
