



The Fund seeks to achieve its investment objective by investing a minimum of 90% of its NAV in the AZ Islamic - MAMG Global Sukuk - MASTER (USD DIS) (Target fund). The remaining 2% - 10% of its NAV will be invested in Islamic liquid assets. The Target Fund aims to achieve its investment objective by actively managing a diversified portfolio of fixed- and/or variable-income debt securities issued by governments, supranational institutions and/or governmental bodies, and/or Shariah-compliant companies.


